ON-LINE TRAINING COURSE CONSTITUTION


In order to increase the impact of the Principle Approach and promote the general good and effectiveness of Principle Approach training to the benefit of all, this Constitution is established for governing teaching and learning throughout the sessions of **The Philosophy and Methods of the Principle Approach: Foundations** Course. The undersigned agree:

- To “lay Christ in the bottom as the only foundation of all sound knowledge and learning” (*New England’s First Fruits*, 1643) with Jesus Christ himself being the chief cornerstone. (Ephesians 2:20b)
- To take 100% responsibility for learning by investing effort in self-directed study and to remain teachable and willing to form new “manners and habits” of teaching and learning. (II Timothy 2:15; Ezra 7:10)
- To hold in mutual respect the expressions of others for the greater purpose of the Gospel and not promote specific church doctrine but communicate by Biblical principles, and to “walk in the Spirit” when interactions with others associated with this course, the Principle Approach Commonwealth, or the Foundation for American Christian Education occur. (Colossians 4:6; Galatians 5:22-25) In that, “[A] man has a property in his opinions and the free communication of them,” (James Madison) I agree to identify my posts to blogs or forums and other communications as my property by not attempting to operate in anonymity and by rightly using communication tools and access to members. (Proverbs 21:23; Psalm 139:4; Matthew 10:32; Romans 1:16)

(Deuteronomy 6:7; Psalm 78:4-8; Matthew 28:19-20)
